1. Sponsors Income

Sponsor income in Direct Selling Company comes from a combination of personal sales commissions and commissions on the sales of those they recruit into the network

Income Calculation: Rs.100/ For every Sponsor. No Limit on Sponsor income.

2. Binary Income

Direct Selling Company where each distributor can directly sponsor and build only two downline teams, referred to as a "left leg" and a "right leg". This structure forms a tree-like network with unlimited depth.

In first Level 1 :2 or 2: 1 Ratio for Binary matching there after 1: 1 Ratio.

Every Binary match gets Rs.100/-

Maximum Daily Capping Rs.2000/- (20 Per Daily)

3. Wallet

We are introducing two wallet system

1. Main Wallet (Known as M Wallet)
2. Ecommerce wallet (Known as E Wallet)

➤ Main Wallet (M Wallet)

All the income credited to main wallet. Every Income Deduct 30 %

Eg: If one Customer get Rs.100/- sponsor income, only credited Rs.70/- in main wallet and balance amount transfer to admin charge, TDS and Ecommerce Wallet.
